Sir / Madam,

Inviting a reference to the subject mentioned above, this is to inform you that the MHA vide above referred letter has conveyed approval of the admissible projects out of the proposals recommended by the State Level and directed to submit alternative proposals against the inadmissible proposals. The lists of admissible and inadmissible proposals are enclosed herewith as **Annexure – I & II** respectively.

2. Accordingly, you are requested to kindly take necessary action for implementation of the **admissible projects** after observing all codal formalities and depending on the physical achievement the requisition of fund is to be placed to Planning Department for release through PFMS portal.


3. The alternative proposals against the inadmissible schemes are to be selected strictly as per the revised guidelines and latest directives issued in this regard by MHA from time to time and same should be submitted in the prescribed formats, along with its enclosures positively by **30/11/2017 both in soft & hard copy**, indicating distance of the villages from International Border as per para 2.1 of BADP guidelines (submitted earlier) along with Non Duplicacy Certificate & Certificates of consultation signed by respective DCs for onward submission to the MHA after due consideration in the forthcoming meeting of the **SLSC scheduled to be held on 04/12/2017**.

4. You are also requested to kindly review the MIS {i.e Name of Village & population (as per 2011 census), Aerial distance of the villages from International Border, Distance of the village as per para 2.1 of the BADP guidelines} for onward submission to MHA for its consideration in subsequent years.
