Sir / Madam,

Inviting a reference to the subject mentioned above, this is to inform you that the MHA vide above referred letter have conveyed approval of the alternative projects recommended by the 33rd Meeting of the State Level Screening Committee on BADP for implementation during 2017-18. The list of approved alternative proposals is enclosed herewith as **Annexure – I**.

2. Accordingly, you are requested to kindly take necessary action for implementation of the approved projects after observing all codal formalities and following necessary instruction issued by the FD in this regard and also satisfying the physical achievement of the projects on the basis of which requisition of fund is to be placed for release through PFMS portal.

3. In consequence upon non submission of pending UC in time, an amount of Rs.649.15 lakh was deducted by MHA and accordingly fund provision for most of the blocks are affected. You are therefore requested to kindly select to implement the prioritized project out of the approved project lists without any deviation for implementation during 2017-18. The left out approved projects for which fund may not be available during 2017-18 is to be incorporated in the AAP for 2018-19.

4. While selecting prioritized projects preference should strictly be follows for Security Related Schemes, Model village, Skill Development and after that other projects can be taken up from the remaining fund without any deviation. The preference of projects should strictly be followed.

5. The district wise provision of fund being placed to the concerned DCs under 2nd installment through PFMS is as follows :-
