Sub:- **Allocation of funds under UNTIED FUND for the year 2017-18.**

Sir/Madam,

I am directed to convey the Govt. approval for placement of Rs 1810.00 lakhs under "Untied Fund" for 2017-18 at the rate of Rs. 50.00 lakh per Deputy Commissioner and Rs. 20.00 lakh per Additional Deputy Commissioner ( with independent charges) at the disposal of respective Deputy Commissioners/Additional Deputy Commissioners.

2. The detail allocation under Untied fund for the year 2017-18 is given at Annexure - I
3. While identifying the projects, following points may kindly be taken into consideration.
  1. The projects to be undertaken under "Untied Fund" shall be finalized by the concerned DC/ADC.
  2. The projects should be confined to the district/sub-division.
  3. There should be no creation of posts.
  4. There should be no purchase of vehicles or office equipment involved.
  5. The projects should not duplicate the effort of the State Plan, and
  6. The projects should be initiated and completed in the same year.
4. The expenditure should be booked under Major Head "4070" Capital outlay on Other Administrative Services - Sub Major Head- 00 Minor Head - 800- Other Expenditure -Sub-Head-18-UNTIED FUND-detailed Head-00 Object Head-53- Major works, Demand No 50.
5. The concerned DCs/ADCs are required to submit Utilization Certificate against the fund released and also detailed list of projects undertaken by them in **soft copy ( Excel )** for further compilation alongwith photographs of the assets created and a brief note indicating cost of the project, implementing department and benefit to the people etc.
6. Expenditure authorization of fund has the approval of competent authority.
7. Independent ADCs may avail the services of DPOs in their respective districts wherever applicable.
