4. The concerned DCs and ADCs are required to submit Utilization Certificates against the fund released, along with a detailed list of projects implemented, photographs of the assets created, and a brief note indicating the project cost, implementing department, and benefits to the people, in **soft copy (Excel)** for further compilation.
5. Independent ADCs may avail the services of District Planning Officers in their respective districts wherever applicable.

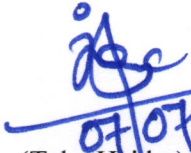
